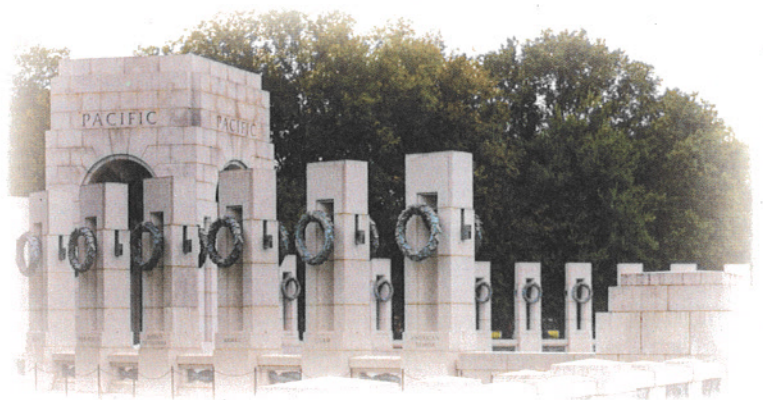
There are many important things we do each day that do not make news headlines. I'm pleased to share with you some highlights of our efforts to support our nation's military servicemembers, their families, and our veterans.

Expanding Veteran Healthcare Options

Congressman Posey is working to expand healthcare options for disabled veterans. Posey is a cosponsor of the **Veterans' True Choice Act** which gives veterans meeting certain criteria the ability to use TRICARE Select and TRICARE for Life. The legislation allows veterans to use community care providers if a local VA facility does not offer the necessary services. Posey said the bill provides more treatment options and flexibility for veterans seeking care.

A Note on the Debt Limit

First, my position always has been and remains the same: I believe that there shall be NO changes to Medicare or Social Security for those in or near retirement. Like Veterans benefits, these are earned benefits and the federal government is obligated to pay them.

In 2010, then-Chairman of the Joint Chiefs of Staff, Admiral Mike Mullen, said the national debt was "the greatest threat to national security." At the time our national debt was \$13 trillion. Today it is more than double that, and according to the New York Times, the new debt limit deal keeps us on a path toward \$50 trillion in debt by 2033, which is why I opposed that deal.

Growth of the national debt is driving inflation and impacts purchasing power of your dollar. Consider that a monthly Social Security benefit of \$1,666 today has the same purchasing power of a \$1,224 monthly benefit from 2010, a loss of \$441 or a 26% decrease in value. Congress must stop kicking this can down the road and deal with this problem.

Meeting Critical Medical Needs of Veterans:

- ✓ **Combating Veterans Suicide** – Supported H.R. 4173 requiring the VA to conduct a study on the outcomes and efficacy of the Veterans Crisis Line.
- ✓ **Fighting Opioid Addiction** – Supported H.R. 3832 requiring medical providers at the VA who prescribe controlled substances to coordinate with state programs that monitor prescription drug use.
- ✓ **Meeting the Needs of Surviving Spouses** – Ending the practice of reducing Survivor Benefit Program benefits by the amount received in Dependence and Indemnity Compensation.
- ✓ **Tracking VA Health Care Complaints – Cosponsored and Supported H.R. 5754 - Patient Advocate Tracker Act** to create an electronic system for veterans to submit complaints regarding healthcare services they receive.

Improving the VA Experience and Protecting Veterans' Rights:

- ✓ **Modernizing the Veterans Appeals Process** – Supported the **Veterans Appeals Improvement and Modernization Act**, to modernize the appeals process at the VA for faster appeals decisions for veterans.
- ✓ **VA Accountability** – Supported the **VA Accountability First Act**, which gives the VA Secretary increased flexibility to remove, demote, or suspend any VA employee for performance issues or misconduct. **VA Same-Day Scheduling Act** requires the VA to schedule an appointment during your first phone call. **Respect for Grieving Military Families Act** prevents government from taking back part of a deceased retiree's last paycheck.
- ✓ **VA ID Card** – Cosponsored law enabling veterans to obtain identification cards from the VA.
- ✓ **Protecting 2nd Amendment Rights** – Ensuring no veteran who utilizes a fiduciary triggers a red flag to lose their Constitutional rights without due process.
- ✓ **Improving VA Transparency** – Supported the **Strengthening Oversight for Veterans Act** to more thoroughly investigate and review allegations into VA employee misconduct.
- ✓ **Upgrading VA Technology** – Requiring the VA to modernize benefits systems.

Economic Opportunities:

- ✓ **Improving the GI Bill** – Removed time restrictions for eligible recipients to use GI bill benefits.
- ✓ **Veterans Employment** – Selected by U.S. House of Representatives to hire a post-9/11 wounded warrior.
- ✓ **Transitioning from Military Jobs to Civilian Jobs** – Supported H.R. 2494 establishing the Veterans Economic Opportunity and Transition Administration.
- ✓ **Expanding Secondary Educational Opportunities** – Supported legislation allowing for easier transfer of earned course credits and for part-time students to access VA Work Study programs.

Border Security is National Security:

- ✓ Working to restore Trump border security first initiatives.
- ✓ Strongly opposes Biden policies of abandoning Trump's successful border security policies.
- ✓ Introduced legislation enabling Americans to contribute to border wall/fence.
- ✓ Ending the Visa Lottery Program which gives out 50,000 lottery entry visas a year regardless of skills or affiliations.

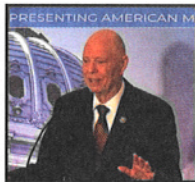


Posey Co-Leads Successful Effort to Bring Space Force's STARCOM to Brevard County

Congressman Posey co-led the Florida Delegation effort with Senators Rubio and Scott to urge the U.S. Air Force to select Brevard County as STARCOM's permanent home. The U.S. Air Force just announced it has selected Patrick Space Force Base and Cape Canaveral Space Force Station as the preferred host of the U.S. Space Force's Space Training and Readiness Command (STARCOM) and Delta 10 unit. Posey said Florida's booming Space Coast is the world's premier space port and the perfect location for Space Force's STARCOM headquarters and Delta 10 unit.

Manufacturing is Key to National Security

Posey's Bipartisan Legislation Holds Chinese Solar Firms Accountable for Violating U.S. Trade Laws

Congressman Posey's bipartisan legislation to support American solar manufacturers and workers and to hold the Chinese Communist Party (CCP) accountable for breaking our trade laws passed the House and Senate with bipartisan support, only to be vetoed by the President.

Posey's bill would have rescinded a recent Biden Administration rule, which the Commerce Department's preliminary investigation found allowed CCP-owned and other foreign solar manufacturers to circumvent U.S. trade laws by delivering their products to the U.S. through third-party countries, all to the detriment of American companies and workers, providing billions in direct relief to Chinese solar companies.

Congressman Posey is a leader in Congress protecting America from the far-reaching influence of China:

- ✓ **Ending Tainted Chinese Pharmaceuticals:** Introduced bipartisan **Safe Medicine Act** to end our reliance on China for lifesaving drugs and protect American patients from contaminated or ineffective pharmaceuticals.
- ✓ **Getting Answers to COVID-19 Pandemic:** Introduced the **PREPARE Act** to expose the origins of the pandemic and hold China accountable.
- ✓ **Promoting CCP Transparency:** Passed an amendment to make sure China plays by the rules and is transparent in international standards-setting bodies.
- ✓ **Defunding Chinese Research:** Introduced legislation to ban American research dollars from the National Science Foundation from benefiting China's state-owned enterprises like the Wuhan Institute of Virology in China.
- ✓ **Putting American Students First:** Passed amendment to ensure public post-graduate STEM research grants are awarded only to American students and institutions.
- ✓ **Bringing Jobs Back Home:** Introduced legislation to provide tax credits to U.S. companies that bring manufacturing jobs back on our shores.
- ✓ **Resisting Chinese Technology:** Blocking Chinese technology from being integrated into our energy and telecommunications grids.

★ Posey Works to Restore Servicemembers Discharged Over Vax Mandate ★

Last year Congressman Posey fought to rescind the military's COVID-19 vaccine mandate for military servicemembers. In December Congress officially passed legislation which was signed into law to remove the mandate. This year Posey has cosponsored legislation (H.R.291 - **Vaccine Discharge Parity Act**) to ensure military servicemembers who were granted a general discharge under honorable conditions for refusing the COVID-19 vaccine are eligible for VA educational assistance under the Montgomery GI Bill and Post-9/11 GI Bill programs as well as certain loan fee rates through March 1, 2031, under the VA's home loan program.

Posey Votes to End Federal Government COVID Telework Policies Responsible for Backlogs

Congressman Posey supported House-passed legislation (H.R. 139) to end telework policies which federal agencies put in place during the pandemic. According to the Office of Personnel Management, about 47 percent of the federal workforce is still working from home. "Getting stuck in lengthy automated phone menus while making little progress to resolve your claim has become the norm – and that must end. Terminating the pandemic-era telework policies will help tackle backlogs and better serve taxpayers," said Posey.

Posey Fights to Eliminate Compensation Barriers for Disabled Veterans

Many disabled veterans have expressed frustration with restrictions on receiving both retired pay and disability compensation concurrently without penalty. Congressman Posey is co-leading several efforts in the House to remove these barriers for disabled veterans by cosponsoring H.R. 1282, the **Major Richard Star Act**, and H.R. 333, the **Disabled Veterans Tax Termination Act**. Both bills address this disparity.
